1AN ORDINANCE OF THE ANCHORAGE ASSEMBLY TO ESTABLISH2GOVERNMENT-TO-GOVERNMENT RELATIONS BETWEEN THE3MUNICIPALITY OF ANCHORAGE AND THE SOVEREIGN NATIVE VILLAGE OF4EKLUTNA BY AMENDING ANCHORAGE MUNICIPAL CODE.

WHEREAS, the municipality recognizes that the Municipality of Anchorage is on the traditional lands of the Dena'ina Athabascan people and that there is inherent value in recognition and formalized government-to-government <u>relations [relationships];</u>

WHEREAS, the municipality passed AR 2019-426 to initiate conversations to formalize a government-to-government relationship with the Native Village of Eklutna;

WHEREAS, the Native Village of Eklutna is the only federally recognized **Tribe** [<u>tribal entity</u>] within the Municipality's boundaries and historically, informal agreements and memorandums have not done enough to ensure a respectful and productive relationship;

WHEREAS, the municipality endeavors to establish permanent and formal, clear and lasting government-to-government relations; now, therefore,

Section 1. Anchorage Municipal Code title 1 is hereby amended to add a new chapter as follows:

1.70 – ACKNOWLEDGMENT AND RECOGNITION

1.70.010 – Land acknowledgment.

Identifies individuals in the municipality who are responsible for 12 developing and implementing municipal programs and projects 13 that affect the Native Village of Eklutna; 14 15 2. Establishes a process to identify programs and projects of the 16 municipality that affect the Native Village of Eklutna; 17 18 3. Promotes communication between the municipality and the 19 Native Village of Eklutna; 20 21 4. Promotes clear and lasting government-to-government 22 relations between the municipality and the Native Village of 23 Eklutna; 24 25 5. Establishes a method for notifying municipal employees of this 26 chapter and of any policy that the municipality adopts under this 27 section. 28 29 3.105.015 – Points of contact. 30 31 The mayor or his/her designee shall be the point of contact between the 32 municipality and the Native Village of Eklutna.
