1 **AN ORDINANCE OF THE ANCHORAGE MUNICIPAL ASSEMBLY AMENDING**
2 **ANCHORAGE MUNICIPAL CODE CHAPTER 4.60 TO ENACT A NEW SECTION**
3 **TO ESTABLISH A HOUSELESS LIVED EXPERIENCE ADVISORY BOARD TO**
4 **PROVIDE THE ASSEMBLY AND MAYOR WITH THE PERSPECTIVE OF**
5 **RESIDENTS WITH LIVED EXPERIENCE AND TO PROMOTE THE**
6 **PARTICIPATION OF OUR CURRENT AND FORMER HOUSELESS**
7 **NEIGHBORS.**

9 **WHEREAS**, the Municipality of Anchorage appreciates the cooperative
10 participation of our houseless neighbors as we continue to confront COVID-19's
11 challenges to our public health and safety; and

12
13 **WHEREAS**, the Municipality values the wisdom shared by our residents whose
14 lives have been shaped in part by the trauma that resulted in their becoming
15 houseless; and

16
17 **WHEREAS**, their voices deepen the Municipality's understanding of the need for
18 our community services to be flexible so that they can be tailored to help each
19 individual overcome the challenges impeding their personal journey into
20 permanent housing; and

21
22 **WHEREAS**, the Anchorage Assembly desires to incorporate the perspective of
23 individuals with lived experience into decisions that will have an impact on our
24 houseless neighbors; now, therefore

25
26 **THE ANCHORAGE ASSEMBLY ORDAINS:**

27
28 **Section 1.** Anchorage Municipal Code chapter 4.60 is hereby amended by
29 adding a new section to read as follows:

30
31 **4.60.250 Houseless Lived Experience Advisory Board.**

32
33 A. There is established a Houseless Lived Experience Advisory Board
34 to provide input and feedback to the assembly and mayor on
35 housing and homelessness solutions with the goal of centering the
36 perspective of those with lived experience. The Clerk's Office or a
37 designee selected by the assembly chair shall act as staff for the
38 board.

40 B. The board shall consist of up to 9 members serving three-year terms
41 who self-identity as having lived experience of homelessness. The
42 following experiences are suggested, but not required, to ensure a

1 variety of perspectives on the board:

- 3 1. Families.
- 4
- 5 2. Youth.
- 6
- 7 3. Single adult.
- 8
- 9 4. Physical disability.

- 11 5. Mental health disorder.

- 13 6. Substance misuse disorder.

- 15 7. Domestic violence survivor.

- 17 8. Veteran.

19 C. The board shall have the following powers and duties:

- 20
- 21 1. Advise the assembly and mayor on issues, services and
22 programs regarding homelessness, housing, and related
23 matters from the perspective of those with lived experience in
24 our community.
- 25
- 26 2. Assist the assembly and mayor in conducting educational and
27 public relations programs designed to create public
28 awareness of the needs of those with lived experience in our
29 community.
- 30
- 31 3. Make recommendations to the assembly and mayor regarding
32 policies, practices, and legislation from the perspective of
33 those with lived experience.
- 34
- 35 4. Act as a liaison between those with lived experience and
36 policy makers.
- 37
- 38 5. Conduct regular reviews of the current community plan to end
39 homelessness from the perspective of those with lived
40 experience.
- 41
- 42 6. To review budget allocations addressing homelessness and
43 support services from the perspective of those with lived
44 experience.

46 D. The board shall sunset on October 14, 2024, unless affirmatively
47 continued by the assembly in accordance with section 4.05.150.

49 **Section 2.** This ordinance shall be effective immediately upon passage by the
50 Assembly.
