PROPOSED AMENDMENT

Purpose/Summary of Amendment: This amendment requires a commitment from the Administration to operate the Golden Lion property as a treatment center as a condition of the appropriation being effective. This is important so that those arriving to the navigation center in need of treatment will have somewhere to navigate to, and because the Golden Lion acquisition was with unrestricted cash from Municipal Light & Power (ML&P) and such use is part of the settlement, and consistent and in accord with it as memorialized in the Stipulation of the Parties and the orders of the Regulatory Commission of Alaska in cases U-18-102, U-19-020, and U-19-021.

AR Page 1, at line 28, amend to insert a new Section 3 and renumber 3 to 4, the new Section 3 to read as follows:

Section 3. The appropriation by this AR is not effective unless and until the Mayor's Administration makes a firm written commitment to make a good faith effort to operate the property at 1000 E. 36th Avenue (formerly Golden Lion Hotel) as a substance misuse treatment center.
